# FIRE PROTECTION PLAN

The goal of the document is to provide strategies that enhance the protection from wildfire for the Summer Village of Jarvis Bay residents and visitors while protecting the health of the forested area while adhering to the communities planning documents.

#### **VISION STATEMENT**

The following are community statements that define the Summer Village of Jarvis Bay:

- 1) We are exclusively a low density, single family residential community
- 2) We are committed to being good and effective stewards of the environment and will act accordingly
- 3) We are committed to providing municipal services that compliment a simple approach to community living
- 4) We are committed to a community that respects and shows pride with regard to public and private spaces
- 5) We will endeavor to communicate, cooperate and work towards creating a better lake environment with all municipalities surrounding Sylvan Lake

## **OPEN SPACE MASTER PLAN**

The majority of residents of Jarvis Bay have chosen the community because of the recreational lifestyle that the Sylvan Lake area offers. Although the current municipal owned land generally is left natural, it is Council's desire to provide an Open Space system that provides a variety of experiences for the residents. Additionally, Jarvis Bay faces pressures from outside users - ranging from parking, private, lessons on public property, to storage - that will require monitoring and possible intervention.

New residential developments should incorporate alternative forms of recreational and open space lands that will meet the needs of the future residents. The lands that do not have direct lakeshore access require a more detailed and comprehensive plan.

Although traffic within the Summer Village does not, as yet, present problems for pedestrians or cyclists, the desire for a trail system that follows Highway 20 alignment is seen as positive by the majority of the residents.

- 1) To maintain the privacy of all residents and ensure that negative impacts of non-resident users are mitigated.
- 2) To maintain and enhance the environmental integrity of the open spaces and provide a greater variety of passive recreational activities.
- 3) To ensure that the provision of open space and reserve land is in balance with the demands of the residents.
- 4) To ensure that public areas do not become an economic burden on local ratepayers.

#### WILDFIRE MITIGATION STRATEGY

## WILDFIRE INCIDENCE

Grass and field fires are the most common type of wildfire in Sylvan Lake. The cause of wildfire is almost exclusively human induced, however, lightning has started fires in the area. The average number of wildfires per year is highly variable and dependent on ignition sources, time of year and fuel types.

#### FIREFIGHTING CAPABILITIES

Sylvan Lake Fire Department relies mainly on volunteer firefighters and provides fire rescue and emergency medical services to Sylvan Lake residents. Bush trucks and mini-pumpers are on pick-up truck chassis and tend to be better suited to action wildfires. The fire department has a water tender, which will benefit remote firefighting by supplying water to areas where water sources may not be readily available.

# **FIRESMART ACTIVITIES**

Jarvis Bay has a LOW hazard rating based on the risk and hazard assessment. The intent of the Fire Smart Activities section is to make recommendations considering wildfire incidence, wildfire behavior potential, existing barriers to the fire spread and values at risk.

# **SUPPRESSION TACTICS**

The initial attack would be conducted with the water that was brought on the trucks by the Sylvan Lake Fire Department water tenders. If additional water was required a couple of scenarios can unfold:

- 1 Tender would locate closest hydrant and shuttle water back and forth from there. Dumping in a porta tank (winter operations, lake frozen). Generally speaking if this scenario was enacted other Tenders from Mutual Aid partners would be dispatched.
- A "turbo draft" device would be deployed from the engine and water would be drafted from a water supply (lake).
- 3 A variation of 1 & 2 could be utilized.

# **EVACUATION ROUTES**

Northern Portion - South on Jarvis Bay Drive, Jarvis Glen Way to Township Road 391 to Highway 20

Southern Portion - Head east to 31 Street, Sylvan Lake or 50 A Avenue, Sylvan Lake Walking Path at the North End of Jarvis Bay Drive through Jarvis Bay Provincial Park

# **PURPOSE**

The purpose of a Fire Protection Plan is to provide an administrative process to document adaptive management by the Summer Village to minimize losses due to a fire. A fire Protection Plan must be completed with the aid and support of fire professionals and industry leaders. Three documents have been developed for the Summer Villages to assist with the completion of their own Fire Protection Plan. When utilized together, the three documents will guide a Summer Village through a step-by-step process to develop their own unique Fire Protection Plan.
