### LAND USE BYLAW

Update and Modernization Project

The Summer Village of Half Moon Bay is undertaking a **focused review and update** to the Summer Village's current Land Use Bylaw.

Alberta's Municipal Government Act requires municipalities to have a Land Use Bylaw. This is not a new requirement; all municipalities have had a Land Use Bylaw for several decades. A Land Use Bylaw establishes rules and regulations for land use and development as well as processes for making decisions on subdivision and development permit applications.

The Land Use Bylaw includes a wide range of regulations, including:

- Development permit application requirements;
- The maximum height, number, and size of buildings on a lot; and
- Lists of permitted and discretionary uses for each land use district.

**The Summer Village of Half Moon Bay's current Land Use Bylaw is over 10 years old.** Since it was adopted, new development pressures and trends have emerged, and provincial legislation related to planning and development has been amended several times by the Government of Alberta.

The Summer Village sent out a project information newsletter and survey to community residents in May 2023. In total, 10 survey responses were received and shared with Council.

Through 2024 and 2025, the Summer Village has developed and reviewed a draft Land Use Bylaw that is now ready for community input.

The primary purpose of this review and update is to address changes to provincial legislation, modernize development permit application requirements, incorporate policies from the Summer Village's statutory plans, and to enable the types of residential and recreational uses that community members have indicated are important as part of the survey responses.

### ONLINE OPEN HOUSE


To Present the Draft Land Use Bylaw and Answer Questions
