Moved by Lenore Berkeley that the Municipal Planning Commission deny the application for 2 setback variances for an existing shed at 44 Jarvis Bay Drive for the following reasons:

- the shed was constructed without a development permit
- the location of the shed does not comply with the Land Use Bylaw
- the shed is currently located in the front yard of the parcel
- the shed is considered a non-conforming structure.
- the Land Use Bylaw Section 2.4 (3) states that "a variance shall be
 considered only where warranted by the merits of the proposed
 development and in response to irregular lot lines, parcel shapes, or site
 characteristics which create difficulties in siting structures within the
 required setback or in meeting the usual requirements." The shed could
 be relocated to a different location on the property to be compliant with
 the setbacks as listed in the Land Use Bylaw
- the shed does not comply with the setback regulations listed in Part 4 of the Land Use Bylaw
